



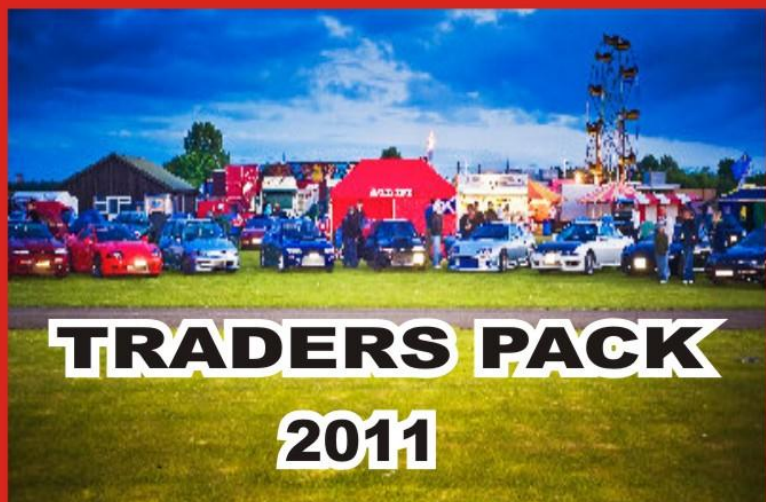

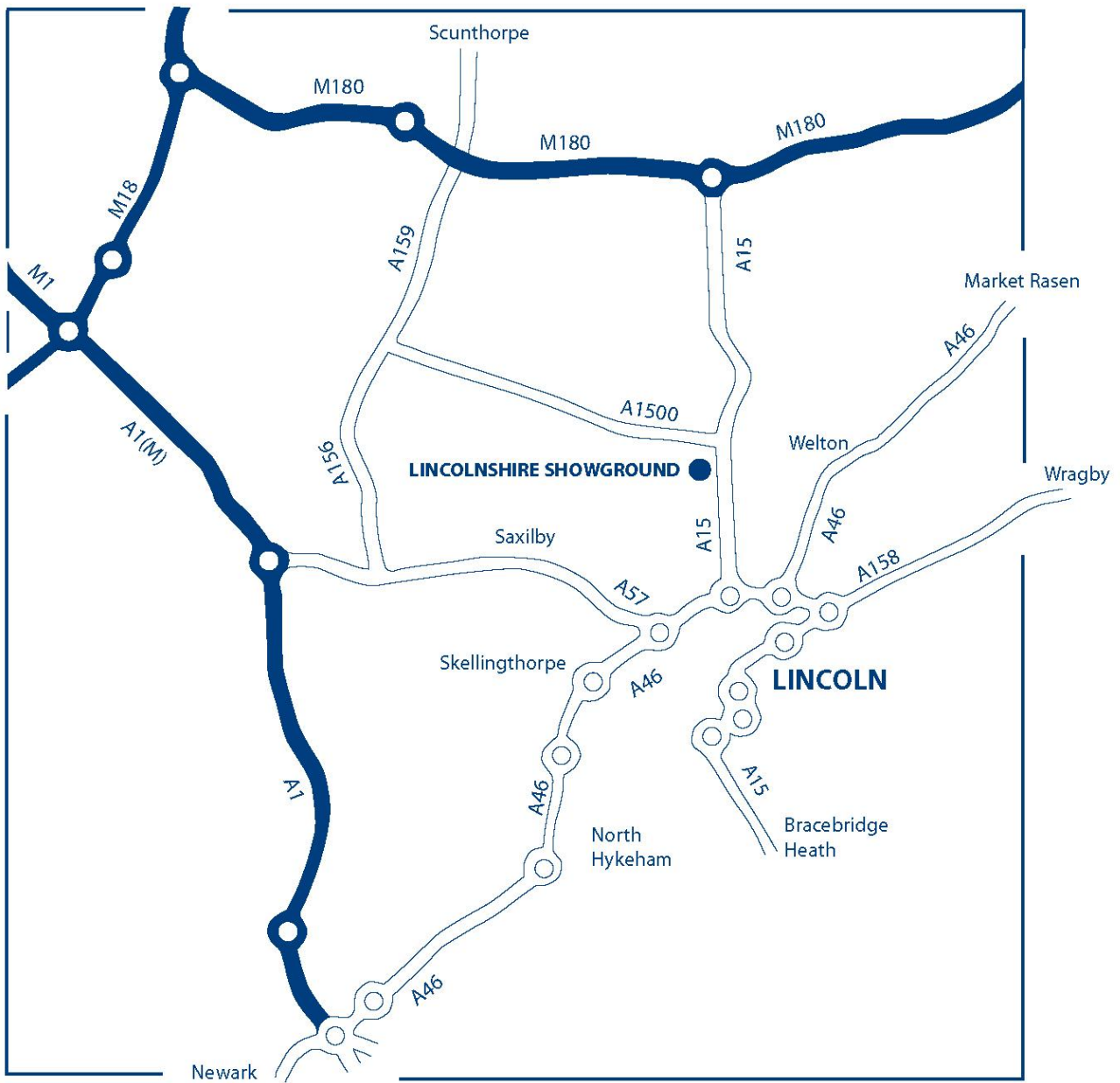

Terms and Conditions

General Details and Safety Information

It is understood that in signing for and purchasing a Trade / Club Stand or Exhibition space for The Rising Sun Car Show (RSCS) That you will adhere to the Terms and Conditions.

The Rising Sun Car Show map layout is only a guide and does not play any part of the contract. We reserve the right to change allocations and plot positions at our discretion. We also reserve the right to refuse admission to any Trader / Exhibitor or there staff at any time.

Exhibitors must check in before proceeding to the main show area. Failure to attend may incur additional fees from Event Organisers, as they reserve the right to pass on any additional fees from the venue to the client(s).

The Exhibitor must indemnify the Event Organisers against all claims, damages or expense whatsoever in any way arising out of his/her attendance or his/her exhibits on the event site. Exhibitors are required to take out the necessary insurance against fire and all other risks including third party claims. The completed booking form for a trade stand shall be deemed as confirmation by the Exhibitor that the necessary insurance cover has been obtained, (I.E Public liability) and the Exhibitor agrees to indemnify the Event Organisers, their staff and their agents against all and any claims which may arise.

Trade / Club Stand holders are responsible for the safe keeping of all goods and items on their stands. Whilst at the show the Event Organisers will not be responsible in any way for the damage or loss of Exhibitors property.

The Exhibitor must indemnify the Event Organisers against all claims, damages or expense whatsoever in any way arising out of his/her attendance or his/her exhibits on the event site. Exhibitors are required to take out the necessary insurance against fire and all other risks including third party claims. The completed booking form for a trade stand shall be deemed as confirmation by the Exhibitor that the necessary insurance cover has been obtained, (I.E Public liability) and the Exhibitor agrees to indemnify the Event Organisers, their staff and their agents against all and any claims which may arise.

The Event Organisers reserve the right to prevent the use of any electrical system which is not installed in accordance with current regulations. Exhibitor's electrical equipment should carry a current copy of a relevant safety certification, which should be available for inspection at the event. Where an exhibitor provides their own electrical supply, this should be installed in accordance with the current regulations for temporary electrical supplies. Further to order the use of such equipment or appliances to be discontinued should they contravene Fire and Safety regulations. Exhibitors must familiarise themselves with fire precautions and are required to supply a suitable fire extinguisher.

Payment

Payment should be made in full as instructed on the form. Any additional bank charges incurred whilst processing payment will be passed on in full. Please make all cheques payable to Rising Sun Car Show. No space will be provided or advertised as attending until payment is cleared. No club / Trader is permitted to sub-letting their area without prior written permission. No refunds will be made in the case of the show cancelling within 30 days of the event start date.

An accurate description of Goods to be sold or exhibited in the trade space must be contained in the booking form. Only items matching this description will be allowed. Drink and Food beverages may not be sold without written permission from the Event Organisers.

All material on display or exhibition equipment shall be positioned within the trade stand allocated. Unless written permission is granted by the Event Organisers prior to the event, distributing leaflets, posters or other billing materials away from the confines of the stand is forbidden

Tombola stands, pick-a-ticket, raffles, pitching and auctioning are not allowed without written permission from the Event Organisers. Air powered guns, knives, catapults, crossbows, firearms of any type and offensive weapons are strictly forbidden.

Without prior written permission from the Event Organisers under no circumstances will any exhibitor be allowed to sell any product or merchandise featuring the Rising Sun Car Show logo.

If there are any discrepancies regarding trade space, then they are to be reported to Rising Sun Car Show staff. No correspondence will be entered into without this prior notice.

You should contact the Organisers office should inclement weather prevent you sitting your exhibit to arrange for a suitable tow vehicle. Under no circumstances should this be attempted by any other party, any ground damage will be charged at cost. The organisers reserve the right without prior notice to arrange an alternative site if inclement weather or adverse ground conditions prevent the use of your allocated site.

Should stands produce a high volume of litter then the exhibitor must provide adequate litter bins. Exhibitors are responsible for the cleanliness of their stands and all rubbish must be removed at the end of the day(s). Any costs incurred for the cleaning up after an exhibitor will be passed on in full.

It is a condition of admission to the show that no commercial (non private) use may be made of any photographic, film or other recording made by you of the Show or any part of it.

Audiences, visitors and exhibitors may be recorded for broadcast, security and health and safety purposes.

Health & Safety at Work Act 1974. In accordance with current legislation, Rising Sun Car Show seeks the co-operation of everyone involved in the show to remember their duty with regards to the above act. In particular that all persons have a responsibility so far as reasonably The Event Organisers reserve the right of inspection by the Fire Prevention Officer of all stands and equipment and practicable for the health, safety and welfare personally and of their employees. This includes the provision of information, instruction, training and supervision as appropriate to enable personnel to carry out their work in a safe manner.

Noise

Noise should be kept to a level such that it does not cause a disturbance to RSCS or other traders, visitors or local residents. Public address systems, loud speaker systems or broadcast devices are expressly forbidden without prior written permission from RSCS. For traders of I.C.E, please be sensible and have volume levels acceptable to RSCS officials.
